

Terms of Service

Upon entering this tuition contract for NAI's instructional program, both parties acknowledge that they have read, understood, and agreed to be bound by its terms and conditions:

Nondisclosure

NAI will provide the student with confidential information related to acupuncture knowledge and techniques. The student agrees to use this information solely for learning the curriculum provided by NAI and not for any other purposes.

Confidential Information: This includes various types of information generated, provided, or produced by NAI during the student's classes. It encompasses neuro-acupuncture techniques, licensed materials, intellectual property, curriculum, writings, databases, business plans, marketing information, and other proprietary information belonging to NAI or provided to NAI by vendors, service providers, faculty members, or affiliates.
